Committee interest in local agencies:

- Meg from East Falmouth Library discussed outcomes of hosting the Summer Eats Program of Project Bread with meals prepared by YMCA Camp Lyndon:
 - o Program ran July 9th to August 22 on Mondays, Tuesdays and Wednesdays
 - East Falmouth Library was named as an open site (meaning any child could go get lunch) and was due to census information on financial criteria of area and also how many children receive free/reduced lunch
 - Main events on Monday, Story times on Tuesdays and Arts and Crafts on Wednesdays; Activities scheduled were for multi-age but mostly attracted kids under 10
 - Total of 426 kids, 289 adults came to the events and 291 meals were served to kids
 - Lunches consisted of sandwiches, veggies, fruit and milk
 - Will be reapplying to be open host site for next summer; will be starting planning stages in March/April

Community Reports:

• Kerin and Sue discussed their representation of the Department at the Emergency Preparedness Fair and encouraged Committee Members to attend next year to learn about all the non-profit agencies providing services in town and help to promote the services of the Department within the Community.
